APPLICATION FOR SPECIAL EXCEPTION, PERMIT OR USE - Submitted by George Norden. For property known as 250 Indian River Road. To establish a retail/service establishment within the existing building. A waiver of the Site Plan and Architectural Design Plan has been requested.

Mr. George Norden, representing Joint Effort Guided Exercise over 50, addressed the Commission with his proposal for an elderly gym to be located at 250 Indian River Road. He was unable to attend the December 2nd meeting and stated how since the last meeting, he submitted an updated application for clarification. Mr. Norden is requesting waivers of the Site Plan and Architectural Designs because he is not changing anything about the existing site.

The Commission discussed how this property is located in the LI-3 District and a gym is considered a service rendered in a primarily retail setting. Retail in the LI-3 Zone is only by special use.
